**Course Number: HUM1010**

**Course Title: The Art of Professionalism**

**Course Description:** Using an inquiry-based approach, students will examine the question, “what does it mean to be a professional?” In addressing this issue, students will focus on conscientious professionalism through awareness of themselves, their fields, and the places of both in the wider world. By exploring what it means to think, look, speak, write, and work as professionals, students identify avenues for academic and career success.

### Quarter Credit Hour Definition

A quarter credit hour is an amount of work represented in intended learning outcomes and verified by evidence of student achievement that is an institutionally established equivalency that reasonably approximates not less than:

(1) One hour of classroom or direct faculty instruction and a minimum of two hours of out-of-class student work each week for 10-12 weeks, or the equivalent amount of work over a different amount of time; or

(2) At least an equivalent amount of work as required in paragraph (1) of this definition for other academic activities as established by the institution including laboratory work, internships, studio work, and other academic work leading to the award of credit hours.

Upon successful completion of the course, the student should be able to:

1. Identify the wider contexts of themselves and their fields of study
2. Compose personal, academic, and professional goals for the quarter, year, career
3. Locate and utilize resources relevant to their fields of study
4. Perform and critique presentations in a professional manner
5. Examine examples of professionals in the past and present
6. Cultivate and maintain a professional persona
