Course Title: Themes in World Civilization

Course Description: Students explore the cultural, intellectual, and political traditions that have framed historical developments from the 18th to the 21st centuries. Recognition, investigation, and analysis of differing cultural perspectives and approaches to the human dilemma are emphasized.

Quarter Credit Hour Definition

A quarter credit hour is an amount of work represented in intended learning outcomes and verified by evidence of student achievement that is an institutionally established equivalency that reasonably approximates not less than:

- (1) One hour of classroom or direct faculty instruction and a minimum of two hours of out-of-class student work each week for 10-12 weeks, or the equivalent amount of work over a different amount of time; or
- (2) At least an equivalent amount of work as required in paragraph (1) of this definition for other academic activities as established by the institution including laboratory work, internships, studio work, and other academic work leading to the award of credit hours.

1. Identify and articulate global events, trends and issues.
2. Construct historical assessments of the contributions of individuals and events, using historical evidence.
3. Relate historical events and cultural perspectives to contemporary situations and issues.
4. Identify key themes in the socioeconomic, intellectual and political development of the world.
5. Compare and contrast ideas, values, beliefs and experiences that have shaped human history and culture.
6. Critically research, analyze and/or evaluate a topic or problem in world civilization.
7. Effectively search, identify and collect information pertaining to a topic or professional area.
8. Use information effectively, individually or as a member of a group, to accomplish a specific purpose.
