Course Title: Introduction to Philosophy

Course Description: This is an introductory study of some of the major problems of philosophy. Among the problems to be considered: the nature of philosophy, problems of knowledge (questions concerning the origin, nature, and limits of knowledge), and the problem of a worldview (metaphysical questions concerning materialism, idealism, and naturalism). Through class lectures, discussions, and readings, students will become familiar with some of the answers that have been given to a variety of philosophical questions.

Quarter Credit Hour Definition

A quarter credit hour is an amount of work represented in intended learning outcomes and verified by evidence of student achievement that is an institutionally established equivalency that reasonably approximates not less than:

(1) One hour of classroom or direct faculty instruction and a minimum of two hours of out-of-class student work each week for 10-12 weeks, or the equivalent amount of work over a different amount of time; or

(2) At least an equivalent amount of work as required in paragraph (1) of this definition for other academic activities as established by the institution including laboratory work, internships, studio work, and other academic work leading to the award of credit hours.

Learning Objectives:

Upon successful completion of the course, the student should be able to:

1. Summarize the historical tradition of philosophy.
2. Identify and examine the major longstanding philosophical problems and the arguments that have been used to explain them.
3. Demonstrate a grasp of the meaning of philosophical inquiry.
4. Discuss the value of a philosophical worldview in providing order to life.
5. Critically research, analyze and/or evaluate a topic or problem.
6. Effectively search, identify and collect information pertaining to a topic or professional area.
7. Evaluate information and its sources critically and incorporate selected information into his or her knowledge base and value system.
