**Course Title:** Spanish I

**Course Description:** This course is an introduction to conversational and written French language. Emphasis is on familiarity with contemporary vocabulary and cultural understanding of the Spanish speaking countries.

### Quarter Credit Hour Definition

A quarter credit hour is an amount of work represented in intended learning outcomes and verified by evidence of student achievement that is an institutionally established equivalency that reasonably approximates not less than:

- (1) One hour of classroom or direct faculty instruction and a minimum of two hours of out-of-class student work each week for 10-12 weeks, or the equivalent amount of work over a different amount of time; or
- (2) At least an equivalent amount of work as required in paragraph (1) of this definition for other academic activities as established by the institution including laboratory work, internships, studio work, and other academic work leading to the award of credit hours.

### Learning Objectives:

Upon successful completion of the course, the student should be able to:

1. Master the fundamentals of Spanish pronunciation
2. Participate in simple question and answer or dialogue in Spanish
3. Demonstrate comprehension through basic oral and written response or translation
4. Employ Spanish to describe limited real situations.
5. Read and write familiar vocabulary in standard Spanish
