Course Description: This course delves further into specific subjects in the area of the social sciences that are not necessarily addressed in the curricula. These topics may include areas in philosophy, ethics, psychology or sociology.

A quarter credit hour is an amount of work represented in intended learning outcomes and verified by evidence of student achievement that is an institutionally established equivalency that reasonably approximates not less than:

- (1) One hour of classroom or direct faculty instruction and a minimum of two hours of out-of-class student work each week for 10-12 weeks, or the equivalent amount of work over a different amount of time; or
- (2) At least an equivalent amount of work as required in paragraph (1) of this definition for other academic activities as established by the institution including laboratory work, internships, studio work, and other academic work leading to the award of credit hours.

Learning Objectives:

Upon successful completion of the course, the student should be able to:

1. Analyze, critically evaluate and articulate a specific societal/professional topic, ideas and themes associated to the socio-cultural, economic and political issues for your professional fields.
2. Compare and contrast ideas, values, and beliefs through an interdisciplinary approach to critically research, analyze and/or evaluate the course topic.
3. Discuss the primary and secondary topics in depth to develop practical solutions to the problems related to the issues presented.
4. Effectively search, identify, collect and appropriately use information, both individually and as a member of a group, pertaining to a topic in the social sciences and fields of study.
5. Propose and argue for creative and effective solutions to the socio-cultural and professional issues raised within the topic of the course.
