Course Title: INFORMATION DESIGN

Course Description: Information design is the practice of organizing data within a logical, coherent framework to help people fulfill their information needs. It can be applied to a variety of platforms including websites, handheld devices, way finding systems and editorial info-graphics. Students will create data visualizations that are dynamic, consumable and engaging presentations of information.
